### **Nominee For Garden Patio Villas Board Position Rules**

1. A Nominee must be a Member in good standing with *Garden Patio Villas*. (Not delinquent in payment of any fee, fine, or other monetary obligation to the Association.)
2. A Nominee must submit, in writing, their desire to be on the Board of Directors by submitting a “Board of Directors Nominee Application.”
3. An interview will be scheduled with all Nominees to go over requirements and submit to a background check.
4. A “Meet and Greet” will be scheduled to get to know all Candidates.
5. Nominees are not allowed to copy ballots.
6. Nominees are not allowed to fill out ballots for other Members.
7. Nominees are not allowed to post on our Association bulletin boards.
8. New Board Members must sign a “Code of Conduct” form to adhere and follow our Governing Documents, Rules & Regulations and Florida Statutes 720.
9. New Board Members must take “Board Certification” class and submit certification within the first 90 days.
10. New Board Members must take a 4 hour annual “Continued Education Class” within the first 90 days.

**Rules must be adhered to by all Nominees. Failure to comply, may result in the automatic withdrawal of a Nominee from the ballot for Board of Directors.**

*All Board Nominee Applications must be submitted not less than thirty (30) days prior to the scheduled election.*
